The program is formulated with the objective of making the Independent Directors of the Company accustomed to their roles and responsibilities which further is divided into various modules with emphasis on:

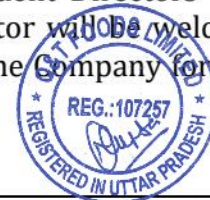
- Nature of Industry in which the Company operates.
